This limited warranty is effective for ninety (90) days from the date of end-user purchaser's receipt of Product shipment (the "Warranty Period") and does not apply to products purchased outside the United States or from an unauthorized dealer, distributor or seller. This limited warranty is not assignable or transferable to any subsequent purchaser or end-user. For this limited warranty to be in effect, prior to actual use, you shall test this Product to determine its suitability for intended use. If, during testing, this Product fails to operate as intended, FUJIFILM shall replace any defective Product upon your return of such Product to the FUJIFILM Technical Center, at the address set forth below, postpaid and insured, within the Warranty Period.
